Add Concord Group Insurance's ESP+ to your insurance policies and receive these benefits:

### Extended Personal Property Limits

- \$1,000 on money, bank notes, bullion, gold, silver, platinum, coins, and medals
- \$2,500 on securities, accounts, and deeds
- \$2,500 on watercraft, including trailers, furnishings, and equipment
- \$2,500 on trailers not used with watercraft
- \$2,500 per item (\$10,000 max) for loss by theft of jewelry, watches, furs, precious or semi-precious stones
- \$3,500 for property used for business in the home
- \$1,000 for property used for business not in the home
- \$2,500 for loss to electronic apparatus while in or upon a motor vehicle
- \$2,500 for loss to electronic apparatus while not in or upon a motor vehicle
- \$3,500 for loss by theft of firearms and related equipment

**Personal Injury Protection:** protection against personal injury claims such as false arrest, libel, wrongful eviction

**Lawn Tractor Property Coverage and Off Premises Liability Extension:** when tractor is used off premises

**Sewer and Water Backup Protection:** an additional \$1,000 for a total \$3,500 with CHEC and \$250 deductible

**Damage to Other's Property:** Up to \$1,500 to replace another person's items that are damaged while in your care

**Credit/Debit Card Theft, Receipt of Counterfeit Money:** Up to \$5,000
